# Modular buildings put squeeze on Rapid City students

This fall, a facilities task force has been assembled to provide recommendations later this school year to the board. They've met privately to discuss, among other issues, plans to alleviate crowded schools. A new elementary school could be on the docket when they make public their recommendations. Population bubbles in the southwest and north of Interstate-90 led to overcrowding at some schools this September, forcing the transfer of 111 students.

### "We have enough capacity across the district," said Veluswamy. "But it's not in the right location."

The 435 students at the Canyon Lake campus technically fit within the classes, but Swank had to move the library to an old gymnasium in the East Canyon Lake building to vacate space for another classroom. Now, kindergarten through first grade are what the school terms "at capacity." They're not the only one. Six schools are over functional capacity. Another five are nearing it. A new building north of the interstate could alleviate crowding in the elementary schools and, potentially if placed correctly, draw down from the <u>180 students from</u> <u>Canyon Lake who live north of Interstate-90</u>. That could, Swank said, free up the annexes to be used as overflow for other schools or something different.

Officials said that **170-plus students who are bused to the school from the city's north side each day** lose out on additional class time because of their long commute.

"If you think about the cognitive capital that kids have at their disposal in a day, they're spending the first hour of that sitting on a bus. And then they're going home tired on a bus with 95 other kids," Swank said. "That creates its own set of issues. I would say 20 percent of our behavior issues are things that take place on the bus."

#### **CONCLUSION:**

There appears to be no rational reason for transferring 170 plus students from North Rapid's 3 Elementary Schools to Canyon Lake Elementary School (where approximately 85 students are taught in temporary buildings) when a total of 514 empty seats are currently available in North Rapid's 3 Elementary Schools (classrooms in permanent buildings) at a much closer geographic locality.

This is called "manufacturing a crisis."
